Board Overview

The El Paso County Historical Commission purpose is to encourage and support programs and research into the history, archeology, and natural history of El Paso and the region.

Duties

The El Paso County Historical Commission has a statutory responsibility to initiate and conduct programs suggested by Commissioners Court. The Commission is charged with preserving the County's heritage for the education, heritage for tourism, and enjoyment of future generations. Additionally, each member must server on a minimum of two subcommittees such as;

•Archaeology •Architectural Preservation •Cemeteries •Finance •Historical Markers •Mission Trail Development Special Committee •Onate Crossing at Old Fort Bliss and Harts Mill Ad Hoc Committee •Outreach and Education •Publicity •Public Policy •Administration (comprised of the chairs of the above listed committees).

Seats

The commissioner's court is responsible for appointing the members of the El Paso County Historical Commission in January of odd-numbered years. Once the board is appointed in January in odd-numbered years, this action creates the number of seats for the board for that two-year term period. If any of these seats are vacated for any reason, a new member can be appointed by the Commissioners Court to fill the vacancy. However, additional seats will not be added during the term. Interested individuals should contact the chair of the Historical Commission to get involved and participate in sub-committees until board seats become available.

Qualifications

In accordance with the law that creates the County Historical Commission, the members of the commission must be residents of the county and individuals who broadly reflect the age, ethnic, and geographic diversity of the county. Each member of the commission must have an interest in historic preservation and an understanding of local history and resources (Sec 318.003, Texas Local Government Code).

Terms

Each term is for two years with no limit on the number of reappointments.

Meeting Time

The Commission meets every 2nd Tuesday of the month.
